- Democracy Action Report Paulette will post hopefully later today
- We do not have active volunteer teams for environment or economic inequality teams
- February 2nd the Rev. Dr. Susan Frederick Gray
  - o 70 reservations so far we need to promote!
  - Finalizing questions
  - Financial goal: close to \$5000 if at all possible; right now at \$2500
  - One of our major donors has authorized us to launch and leverage a matching opportunity for UUSJ throughout the year (not just this event in particular)
  - Any advertising strategies that we have should be sent to Pablo
- Equity Mapping Training
  - Successfully registered 110 people about 89 showed up the first night
  - Some folks found it really empowering; others were worried at the beginning of the program but were satisfied by the end
- Communications Assistant

- The timetable has been delayed but going through a short list now
- We have a few people who have shown interest recently
- The right combination of what advocacy is about, communications as the forefront of their skills, hopefully with a UU background/affiliation.

## Upcoming advocacy plans

- Two highly functioning teams are reviewing their priorities
- Immigration Action team Comprehensive immigration reform with important conversations of their values and principles
- Democracy Action Team still figuring out their priorities. Holding conversations on notions of bipartisanship in terms of their values and principles.
- Pablo has announced UUSJ involvement with the Farm Bill due to alignment in our goals.
  - Working with Vonna for the past few months to bring on a fully accountable partner for this space - need to finalize the agreement, Pablo will announce as soon as it's finalized.
- We've found a new onramp for potential involvement with calls during the lame duck Congressional period

- Only two of our Priorities have a solid group leading the work
